Enclosed you will find the application for the Lodge No. 2 scholarship grant. It is the intent of Lodge No. 2 to offer up to 4 new scholarship grants annually.

The award amounts are as follows:

a.	Full-time undergraduate studies	\$500.00
b.	Part-time undergraduate studies	\$500.00
c.	Full or part time Graduate Studies	\$500.00

Requirements for application:

- 1. Applicant must either be a member, wife, child or dependent (IRS definition) of a member of Lodge No. 2.
- 2. The Lodge may consider one Non-Legacy scholarship eligibility per annum. A Lodge No. 2 member may nominate a candidate for scholarship outside of the traditional criteria and seek a worthy candidate who excels in the community and exemplifies good civic and charitable work.
- 3. The applicant must be a high school graduate, or high school senior, who is scheduled to attend a college or university with a course study in pursuit of a degree or certificate from an accredited college or university.
- 4. Applicant must have a 2.5 or better GPA.
- 5. A copy of your grades from your last completed semester and a copy of your current class roster (or tuition payment form) MUST be included to be considered for the scholarship.
- 6. The applicant or their Masonic member must be a member in good standing and current with dues to Lodge No. 2.
- 7. If the applicant is a member, or if a member is representing an applicant, he must attend meetings on a consistent basis, or give a reason why he is unable to attend meetings.
- 8. Incomplete scholarship applications will not be considered

Additional information for consideration. Required for a Non-Legacy applicant

 The applicant should be active in school activities (i.e. sports, clubs, committees, etc.), as well as help with the community with charitable or service projects. Documentation of school involvement and community service should be included with the application.

The following application and supporting documentation should be submitted to the Lodge no later than July 31<sup>th</sup>. The applicant will be notified of the committee's decision by August 31<sup>st</sup>, and if a grant is awarded it will be awarded at the Lodge's next Stated Meeting. Held on the first Tuesday in September.
